

- I am the owner of land lying to the south east of Church Lane Gaydon
   ("the Land") which is shown edged red on the attached plan marked "JR1"
   ("the Plan") and which is registered at H M Land Registry under Title
   Number WK343982.
- 2. I purchased the land on 1<sup>st</sup> September 2005.
- 3. The Land has the benefit of a right of way over an accessway shown coloured brown on the Plan ("the Accessway") which leads from Church Lane to the Land.
- 4. Since the date of my purchase I have used the Accessway with agricultural vehicles as a means of access to the land for the purpose of cutting and removing hay from it
- 5. The exercise of this right has been without payment to any person. I have not had to obtain consent from anyone for use of the Accessway and no-one has attempted to prevent me from using the Accessway or obstruct the same.
